Information about collected data and permissions

For the correct operation of the application and business processes of the corporation, we collect your data and request some permissions from your device.

You can opt-out of the transfer of this data, and refuse access to certain device functions. In this case, we cannot guarantee the correct operation of the mobile application, and the ability to conduct transactions using it.

We use:

1) contact and personal data (email, phone number, full name, date of birth, place of work): are used to generate documents when conducting a transaction with your participation, and to contact you if necessary, clarifications in the course of work.

2) approximate location (city): used to generate documents when conducting a transaction with your participation, and to import real estate data in your city.
